### **INVITATION TO PROSPECTIVE AND CURRENT GOODS AND SERVICE PROVIDERS TO REGISTER ON THE SUPPLIER DATABASE. (2013 – 2014)**

In terms of the Municipal Financial Management Act (Act 56 of 2003) every Municipality is required to have a Preferred Supplier Database.

All purchases for the municipality for goods and services may only be made from registered preferred suppliers from the database. We are in process of updating our supplier database and request all prospective suppliers to register and current registered suppliers to check that their info are still up to date.
